- ❖ What Currency does The Hans Foundation accept online donations in?

The Hans Foundation accepts online donations only in Indian Rupees (INR).

- ❖ I am not an Indian resident; can I make a donation?

You can only make online donations if you are an Indian resident with a valid PAN (Permanent Account Number) Card.

- ❖ Is the website safe to make online payments?
